PURPOSE OF THIS EXHIBIT

This email chain shows that on May 15, 2026 — before either parent enrolled Rae at any school — Gisela Sanchez (BVSD Child Find Program Bilingual Assistant) asked both parents which address to use as the primary household for BVSD enrollment purposes. Petitioner Lauren Dorsey responded that she lived in Longmont and explicitly stated: *"If you want to put the address in Ward that works."* BVSD confirmed that Ward (Respondent's address) had to be used because Petitioner's Longmont address fell within St. Vrain Valley School District (SVVSD) — a different district — not BVSD. Using Ward as the enrollment address was not a unilateral decision by Respondent; it was (1) a geographic necessity determined by BVSD, and (2) expressly agreed to by Petitioner.

KEY PASSAGE — May 15, 2026 (Gisela Sanchez to Lauren Dorsey):

"Ok then Dad will have to be the primary household his address is the BVSD household. If you want your address to be a primary household you will have to contact Child Find in SVVSD."

"Sounds good we will use Dads address. Since your address lands on the SVVSD area."

KEY PASSAGE — May 15, 2026 (Lauren Dorsey to Gisela Sanchez):

"We split 50/50 so there isn't really primary. You can put me as primary as I live in town"

[After Gisela asked whether Rae would attend a BVSD school:]

"I currently live in Boulder County. And am moving to Boulder"
